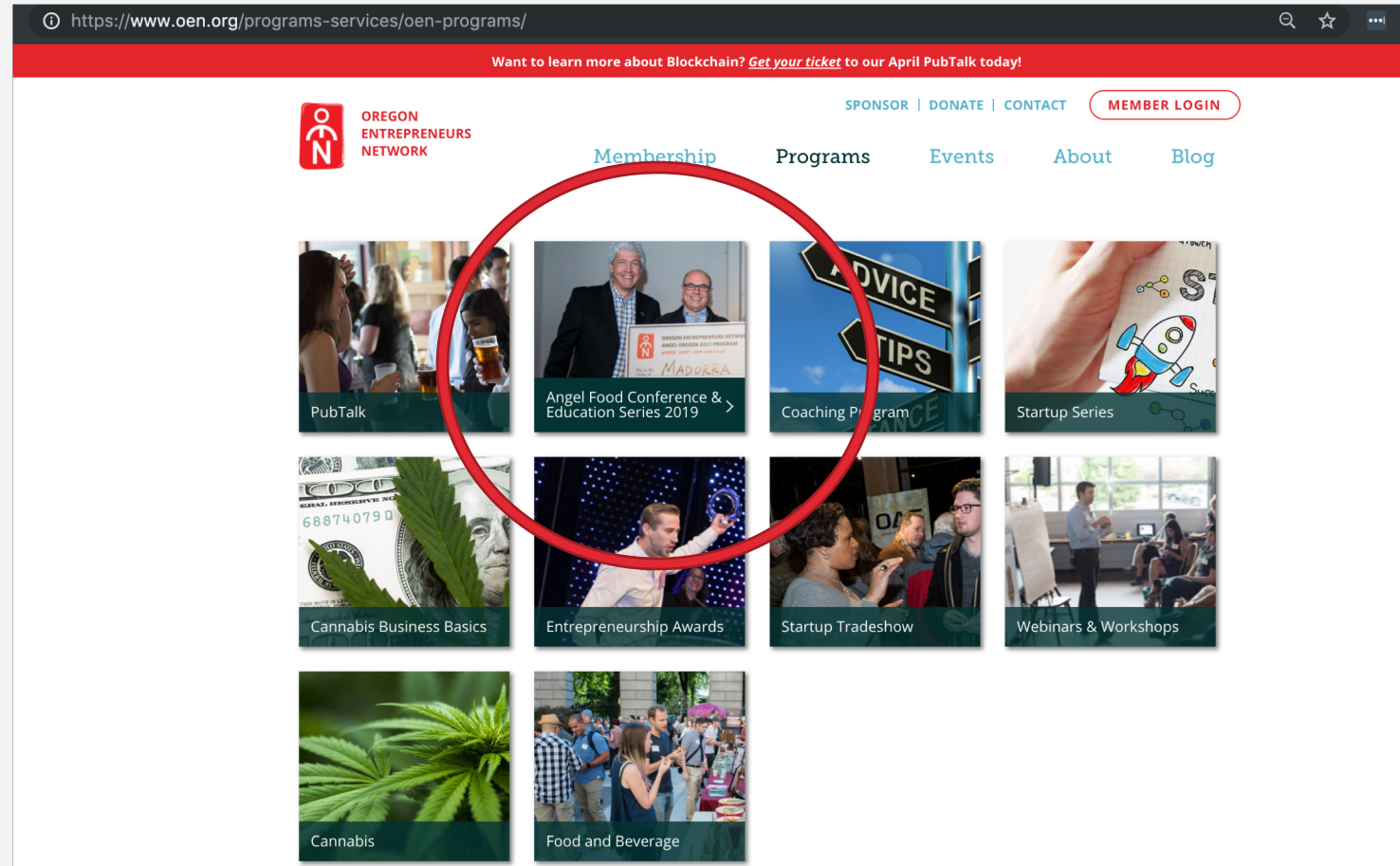

## Concept Stage Category

Companies that apply in our Concept Stage category will get admission to all four educational sessions, have an opportunity to pitch at the May PubTalk Pitchfest, will compete for a package of goods and services at the Angel Food Conference and will have a table at the Food Fair (if they have a viable product in time). In 2017, the first-place prize package for Angel Oregon included approximately over \$20,000 worth of executive coaching services, strategic forecasting consulting, accounting services, and legal services.

Companies participating in the concept stage competition typically:

- Have a great idea, and are close to “proof of concept”
- Are in the process of testing their product in the market
- Have little if any revenue – yet

## Startup Stage Category

Companies that apply in our Startup Stage category will get admission to all four educational sessions, will have a table at the Food Fair, and will go through a due diligence process to compete for an investment award of approximately \$100K+ (actual investment will depend on the number of investors). All applicants will be supported by a network of mentors and experts in the food and beverage sector.

Companies participating in the Startup Stage competition typically:

- Have a proven concept and a complete business plan developed
- Have a product and are selling it “somewhere” (farmer’s markets, local stores, national chains, etc).
- Have generated initial revenues of up to \$250K and are ready for market expansion
- Non-consumer products companies like restaurants are eligible to go through the program but are not eligible to compete for the investment.

Companies that apply in our Developing Stage category will get admission to all four educational sessions, will have a table at the Food Fair, and will go through a due diligence process to compete for an investment award of approximately \$100K+ (actual investment will depend on the number of investors). All applicants will be supported by a network of mentors and experts in the food and beverage sector.

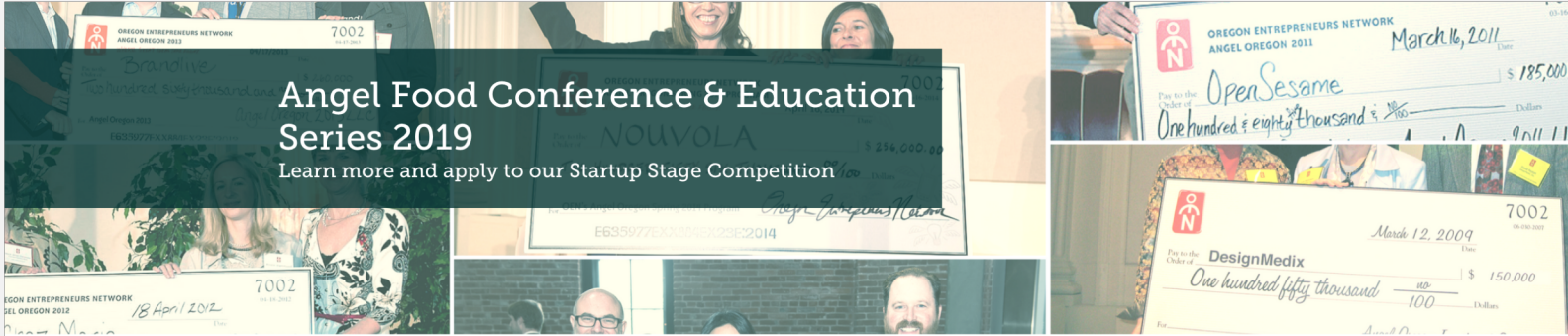


